As a member of this Association you agree to pay all membership dues and fees as established by the Board of Directors and on your own initiative to thoroughly familiarize yourself with the Code of Ethics of the National Association of REALTORS®, including the duty to arbitrate business disputes in accordance with the Code of Ethics and Arbitration Manual of the Williamson County Association of REALTORS®, The State Association and the National Association.

NOTICE: Should your sponsoring Designated REALTOR® change from the one shown on this application you **MUST notify the Association office in writing within ten (10) working days.**

THE 7 POINT MEMBERSHIP CRITERIA OF THE NATIONAL ASSOCIATION OF REALTORS® FOR APPLICANTS FOR REALTOR® MEMBERSHIP:

1. Applicant must hold a valid real estate license and be actively engaged in the real estate business and its recognized branches.
2. Applicant must be employed by a Designated REALTOR® or affiliated with a Designated REALTOR® as an independent contractor.
3. Applicant must make written application for REALTOR® membership in the Association.
4. Applicant must signify intention to abide by the NATIONAL ASSOCIATION OF REALTORS® Code of Ethics.
5. Applicant must signify intention to abide by the Constitution, Bylaws, Policy and Rules & Regulation of the local Association, the State Association of REALTORS® and the NATIONAL ASSOCIATION OF REALTORS®.
6. **Applicant must complete the Association Orientation Course and Induction within one hundred and twenty (120) Days of Application.**
7. **Applicant must complete a Code of Ethics Training Session within one hundred and twenty (120) Days of Application.**
